SUPPLEMENTAL INTERIM ORDER

IN THE MATTER OF THE PROPOSED DESIGNATION OF AN INTENSIVE GROUNDWATER USE CONTROL AREA IN TREGO, ELLIS, RUSH, AND RUSSELL COUNTIES, KANSAS

The Chief Engineer, Division of Water Resources, Kansas State Board of Agriculture (hereinafter referred to as the "Chief Engineer") after due consideration, makes the following Findings and Order.

FINDINGS

- That on May 31, 1984, the Chief Engineer issued an Interim Order designating an Intensive Groundwater Use Control Area in Trego, Ellis, Rush, and Russell Counties, Kansas (hereinafter referred to as "Smoky Hill IGUCA").
- 2. That Paragraph 11 of the Interim Order dated May 31, 1984 initiated proceedings for the extension of the Smoky Hill IGUCA into an area which is described more specifically in that same paragraph.
- 3. That public meetings were held in Russell Springs, Kansas, on July 15, 1986 and in Gove, Kansas, on July 16, 1986 for public input into the proposed extension of the Smoky Hill IGUCA.
- 4. That testimony received at the public meetings suggested the possible inclusion of additional areas within the proposed boundaries for the extension of the Smoky Hill IGUCA.

5. That further hydrologic study indicates that the proposed boundaries for the extension of the Smoky Hill IGUCA should include an additional area as described below:

GOVE COUNTY

Township 12 South, Range 29 West, Sections 19 and 30

Township 12 South, Range 30 West, Sections 13, 14, 23 through 27 and 34 through 36.

ORDER


NOW, THEREFORE, It is the decision and order of the Chief Engineer that in addition to the area described in paragraph 11 of the Interim Order issued May 31, 1984, the proposed boundaries for the extension of the Smoky Hill IGUCA shall contain the area described below:

GOVE COUNTY

Township 12 South, Range 29 West, Sections 19 and 30

Township 12 South, Range 30 West, Sections 13, 14, 23 through 27 and 34 through 36.
