This checklist will help guide you through various resources and requirements for opening and operating a typical Kansas dairy farm. In addition to license requirements by KDA, other Kansas agencies, as well as local or federal government agencies, may have regulatory requirements to follow. Contact your local planning authority to ensure you follow all local business development laws, rules, regulations and guidelines. This guide is designed to assist you as you work to build and operate a successful dairy farm in Kansas.

Detailed plans of the milking facility and cattle housing areas must be submitted to KDA for approval. 	Department of Agriculture — Division of Animal Health  <a href="http://www.agriculture.ks.gov">www.agriculture.ks.gov</a>	Operations with a one-time capacity of more than 1,000 head must complete a <a href="#">Confinement Facility License</a> application. For a multiple herd source dairy genetic sale or any other occasional sale of livestock, complete the <a href="#">Occasional Sales Application</a> .  Interstate shipment of dairy cattle requires official identification of all animals, regardless of sex or age, and a certificate of veterinary inspection or other documentation. Sexually intact dairy cattle over 6 months of age imported into Kansas must have a negative tuberculosis test conducted within 60 days prior to movement into Kansas. Consult the Division of Animal Health <a href="#">Import and Export Regulations</a> for a complete list of requirements or call 785-564-6601. Before exporting livestock from Kansas, contact the <a href="#">state of destination</a> for their livestock import requirements. 	Department of Agriculture — Division of Water Resources  <a href="http://www.agriculture.ks.gov">www.agriculture.ks.gov</a>	The state of Kansas requires a permit for water used for stockwatering. Stockwatering is the watering of livestock and other uses of water directly related to the operation of a feedlot with the capacity to confine 1,000 or more head of cattle; or any other confined livestock operation that would divert 15 or more acre-feet (4.88 million gallons of water) per calendar year. Any group of feedlots or confined feeding operations may be considered to be one operation if there are common feeding or other physical facilities and the group of facilities is under common management. 	Department of Agriculture — Weights and Measures  <a href="http://www.agriculture.ks.gov">www.agriculture.ks.gov</a>	<p>No license is needed from Weights and Measures. Any business with a weighing or measuring device (e.g. scales, fertilizer meters, oil meters, measuring tapes, electric car chargers, taxi meters, etc.) must hire a <a href="#">licensed service company</a> to inspect and test devices once annually, and any time additional maintenance, repairs, adjustments and calibrations are made throughout the year if the devices are used to determine the cost of any transaction.</p> <p>Examples include scales at grocery stores, yogurt shops, restaurants, hardware stores, nurseries, seed dealers, etc. Examples of meters include meters used at a car service center to add oil to your engine, fertilizer meters at agronomy centers, water meters in grocery stores for sale of bottled water, etc. For more information, visit the <a href="#">Weights and Measures Program</a> webpage or call (785) 564-6681.</p>	Annual service
	Department of Health and Environment — Bureau of Water, Livestock Waste Management Section  <a href="http://www.kdheks.gov">www.kdheks.gov</a>	<p>Any facility that confines 300 animal units or more or has a daily discharge must <a href="#">register</a> with the Kansas Department of Health and Environment (KDHE). Animal units can be calculated on the registration form. The need for additional permits and nutrient management plans will be determined based upon the number of animal units and pollution potential. Review the <a href="#">Regulatory Guidance for Large Dairy Operations</a> handbook. Additional requirements may exist if a facility of any size is considering composting. 	Department of Health and Environment — Bureau of Water, Public Water Supply and Geology & Well Technology Section  <a href="http://www.kdheks.gov">www.kdheks.gov</a>	<p>If the facility will not utilize a municipal public water supply or rural water supply as the source of drinking water and the facility will serve 25 people or more per day, 60 or more days per year, it will be considered a public water supply subject to state/federal drinking water requirements. Contact the <a href="#">KDHE Public Water Supply Section</a> at (785) 296-5514.</p> <p>Water wells shall be constructed by Kansas-licensed water well contractors. There are special construction requirements for water wells serving public water supplies.
