Contact your local planning authority to ensure you follow all local business development laws, rules, regulations and guidelines. This guide is designed to assist you as you work to build and operate a successful fertilizer business in Kansas.

To register a fertilizer product, review the <u>Fertilizer Product Instructions</u> and complete the <u>Fertilizer Product Registration</u> or email <u>KDA.pestlabels@KS.gov</u> company and contract information in order to obtain access to register through the online portal. Bulk fertilizer facilities, including liquid and dry fertilizer, may need secondary containment and load pads depending on the amount of fertilizer handled. 		A <u>Fertilizer Blender License</u> is required for anyone who blends only registered commercial fertilizers at the request and according to specifications furnished by the customer or purchaser. 	Department of Agriculture — Weights and Measures <u>www.agriculture.ks.gov</u>	webpage or call (785) 564-6688. No license is needed from Weights and Measures. Any business with a weighing or measuring device (e.g. scales, fertilizer meters, oil meters, measuring tapes, electric car chargers, taxi meters, etc.) must hire a <u>licensed service company</u> to inspect and test devices once annually, and any time additional maintenance, repairs, adjustments and calibrations are made throughout the year if the devices are used to determine the cost of any transaction. 		Examples include scales at grocery stores, yogurt shops, restaurants, hardware stores, nurseries, seed dealers, etc. Examples of meters include meters used at a car service center to add oil to your engine, fertilizer meters at agronomy centers, water meters in grocery stores for sale of bottled water, etc. For more information, visit the <u>Weights and Measures Program</u> webpage or call (785) 564-6681.	
	Department of Health and Environment — Bureau of Water, Industrial Program Section	An <u>NPDES Construction Stormwater Permit</u> is required only if one or more acres are disturbed during construction. The permit is required prior to the start of soil disturbing activities (construction). 	Department of Health and Environment — Bureau of Environmental Remediation, Storage Tank Section <u>www.kdheks.gov</u>	Entities operating their own fuel tanks may be required to register with the Kansas Department of Health and Environment (KDHE). Review information about aboveground storage tanks (AST) and underground storage tanks (UST). Review the <u>KDHE Storage</u> <u>Tank Section</u> website for further information, or call (785) 296-1678 for permitting information. The <u>Kansas Small Business Environmental Assistance Program</u> (SBEAP) has AST program highlights and registration requirements in addition to assistance with UST inventory control.	Prior to installing tanks, Annual renewal August 1
	Department of Health and Environment — Bureau of Water, Public Water Supply and Geology & Well Technology Section <u>www.kdheks.gov</u>	If the facility will not utilize a municipal public water supply or rural water supply as the source of drinking water and the facility will serve 25 people or more per day, 60 or more days per year, it will be considered a public water supply subject to state/federal drinking water requirements. Contact the <u>KDHE Public Water Supply Section</u> at (785) 296-5514. Water wells shall be constructed by Kansas-licensed water well contractors. There are special construction requirements for water wells serving public water supplies. For more information, contact the <u>KDHE Geology & Well Technology Section</u> at (785) 296-7265. 	Department of Health and Environment — Bureau of Water, Municipal Program Section <u>www.kdheks.gov</u> <u>kslepp.org</u>	If the facility will employ an on-site wastewater treatment system for human wastewater rather than utilize a municipal sanitary sewer for handling and disposal of sewage from the facility, contact the <u>KDHE Municipal Program Section</u> at (785) 296-5527 for construction and permitting requirements.	Prior to construction
	Department of Health and Environment — Bureau of Air <u>www.kdheks.gov</u>	Equipment such as conveyors, hoppers, blending tanks, etc. may require a permit from the <u>KDHE Bureau of Air</u> . You must submit the Notification of Construction or Modification application form, appropriate <u>Process/Equipment forms</u> and receive a permit before commencing construction or installation of equipment. <u>Gasoline dispensing</u> <u>facilities</u> are subject to federal air regulation. Refer to <u>Standard Construction Permit/</u> <u>Approval for Gasoline Dispensing Facilities</u> if applicable.
