



Fertilizer Sales, Blending and Storage Licensing Guide

The Kansas Department of Agriculture (KDA) is devoted to the total support of agriculture in Kansas. While we must fulfill our statutory obligations, the department is dedicated to providing support and assistance to make Kansas farms, ranches and agribusinesses successful and help them grow if that is their desire. We also encourage more farms, ranches and other agriculture businesses to expand in or relocate to Kansas. This checklist will help guide you through various resources and requirements for opening and operating a typical Kansas fertilizer business. In addition to license requirements by KDA, other Kansas agencies, as well as local or federal government agencies, may have regulatory requirements to follow. Contact your local planning authority to ensure you follow all local business development laws, rules, regulations and guidelines. This guide is designed to assist you as you work to build and operate a successful fertilizer business in Kansas.

	Department of Agriculture — Pesticide and Fertilizer www.agriculture.ks.gov	<p>All fertilizers sold must be registered. To register a fertilizer product, review the Fertilizer Product Instructions and complete the Fertilizer Product Registration.</p> <p>Bulk fertilizer facilities, including liquid and dry fertilizer, may need secondary containment and load pads depending on the amount of fertilizer handled. Consult the flow charts on the Secondary Containment webpage to determine if secondary containment is required. If secondary containment is required, complete the Secondary Containment Application. 	Department of Agriculture — Weights and Measures www.agriculture.ks.gov	<p>No license is needed from Weights and Measures. Any business with a weighing or measuring device (e.g. scales, fertilizer meters, oil meters, measuring tapes, electric car chargers, taxi meters, etc.) must hire a licensed service company to inspect and test devices once annually, and any time additional maintenance, repairs, adjustments and calibrations are made throughout the year if the devices are used to determine the cost of any transaction.</p> <p>Examples include scales at grocery stores, yogurt shops, restaurants, hardware stores, nurseries, seed dealers, etc. Examples of meters include meters used at a car service center to add oil to your engine, fertilizer meters at agronomy centers, water meters in grocery stores for sale of bottled water, etc. For more information, visit the Weights and Measures Program webpage or call (785) 564-6681.</p>	Annual service
	Department of Health and Environment — Bureau of Water, Industrial Program Section www.kdheks.gov	An NPDES Construction Stormwater Permit is required only if one or more acres are disturbed during construction. 	Department of Health and Environment — Bureau of Environmental Remediation, Storage Tank Section www.kdheks.gov	Entities operating their own fuel tanks may be required to register with the Kansas Department of Health and Environment (KDHE). Review information about aboveground storage tanks (AST) and underground storage tanks (UST). Review the KDHE Storage Tank Section website for further information, or call (785) 296-1678 for permitting information. The Kansas Small Business Environmental Assistance Program (SBEAP) has AST program highlights and registration requirements in addition to assistance with UST inventory control . 	Department of Health and Environment — Bureau of Water, Public Water Supply and Geology & Well Technology Section www.kdheks.gov	If the facility will not utilize a municipal public water supply or rural water supply as the source of drinking water and the facility will serve 25 people or more per day, 60 or more days per year, it will be considered a public water supply subject to state/federal drinking water requirements. Contact the KDHE Public Water Supply Section at (785) 296-5514. Water wells shall be constructed by Kansas-licensed water well contractors. There are special construction requirements for water wells serving public water supplies. For more information, contact the KDHE Geology & Well Technology Section at (785) 296-3565. 	Department of Health and Environment — Bureau of Water, Municipal Program Section www.kdheks.gov	If the facility will employ an on-site wastewater treatment system for human wastewater rather than utilize a municipal sanitary sewer for handling and disposal of sewage from the facility, contact the KDHE Municipal Program Section at (785) 296-5527 for construction and permitting requirements. 	Department of Health and Environment — Bureau of Air www.kdheks.gov	Equipment such as conveyors, hoppers, blending tanks, etc. may require a permit from the KDHE Bureau of Air . You must submit the Notification of Construction or Modification application form , appropriate Process/Equipment forms and receive a permit before commencing construction or installation of equipment. Gasoline dispensing facilities are subject to federal air regulation. Refer to Standard Construction Permit/Approval for Gasoline Dispensing Facilities if applicable.
