**Foliar Applications**

**Maximum Application Rate:** If no more than 0.1 lb a.i. (6.25 fl. oz. or 0.4 pts. of product) has been applied during the annual alfalfa growing season, Warrior II with Zeon Technology may be applied at 1.28 - 1.92 fl. oz. per acre after the last annual cutting and before alfalfa and insects become dormant to help reduce overwintering populations of alfalfa insect pests and subsequent insect populations the following spring. Treatments in this management program are part of the total annual maximum active ingredient allowed per acre per season.

- Apply Warrior II with Zeon Technology as a broadcast foliar spray with either ground or aerial application equipment.
- Use a minimum of 10 GPA by ground or 2 GPA by aerial application. When foliage is dense and/or pest populations are high 5–10 gals. per acre by air or 20 gals. per acre by ground and higher use rates are recommended. Use higher rates for increased residual control.
- Warrior II with Zeon Technology is labeled for chemigation application. Refer to Chemigation use directions on the full Warrior II with Zeon Technology label for details on this application.
- Make applications when insect populations reach economic thresholds or when significant feeding is occurring.
- This product is highly toxic to bees exposed to direct treatment. Avoid application when bees are actively foraging by applying during the early morning or during the evening hours. Be aware of bee hazard resulting from a cool evening and/or morning dew. It may be advisable to remove bee shelters during and for 2–3 days following application. Avoid direct application to bee shelters.
- Observe all spray drift precautions on the EPA registered label.
- Refer to local Cooperative Extension Pest Management Guidelines and/or scouting results.

#### **RESTRICTIONS:**

- Do not apply within 1 day of harvest for forage or within 7 days of harvest for hay or seed.
- Do not make applications of Warrior II with Zeon Technology or follow with other products containing lambda-cyhalothrin less than 7 days apart.
- Do not exceed 7.68 fl. oz. /A (0.12 lbs. a.i.) or make more than 4 applications of Warrior II with Zeon Technology at 1.92 fl. oz./A (0.03 lbs. a.i.) or other products containing lambda-cyhalothrin per season.
- Re-entry Interval: 24 hours. Personal protective equipment is required for early entry.
