

The Kansas Department of Agriculture (KDA) is devoted to the support of agriculture in Kansas. While we must fulfill our statutory obligations, the department provides support and assistance to make Kansas farms and agribusinesses successful and help them grow if that is their desire. We also encourage more farms and other agriculture businesses to expand in or relocate to Kansas. This guide is designed to assist you as you work to build and operate as an industrial hemp producer in Kansas. In addition to license requirements by KDA, other Kansas agencies, as well as local or federal government agencies, may have regulatory requirements to follow. Contact your local planning authority to ensure you follow all local business development laws, rules, regulations, and guidelines.

	Kansas Department of Agriculture, Weights and Measures <u>agriculture.ks.gov/</u> <u>weight-measures</u>	No license is needed from Weights and Measures. Any business with a weighing or measuring de- vice (e.g. scales, fertilizer meters, oil meters, measuring tapes, electric car chargers, taxi meters, etc.) must hire a licensed service company to inspect and test devices once annually, and any time additional maintenance, repairs, adjustments, and calibrations are made throughout the year if the devices are used to determine the cost of any transaction. Examples include scales at grocery stores, yogurt shops, restaurants, hardware stores, nurseries, seed dealers, etc. Examples of meters include meters used at a car service center to add oil to your engine, fertilizer meters at agronomy centers, water meters in grocery stores for sale of bottled wa- ter, etc. For more information, visit the Weights and Measures Program webpage or call (785) 564- 6681. 	Kansas Department of Agriculture, Food Safety and Lodging Program <u>agriculture.ks.gov/fsl</u>	If the hemp product is offered as a food and requires temperature control or is provided by the serv- ing to order, a Food Establishment license is required. If food products are offered for resale or fur- ther distribution, a Food Processing license is required. 	Department of Agriculture — Division of Pesticide and Fertilizer <u>agriculture.ks.gov/</u> <u>pesticide-fertilizer</u>	Any retail business or person who sells a pesticide to another person for application must complete the Pesticide Dealer Registration and Application. Any person or business that applies pesticides is required to be licensed as a pesticide business by completing the Pesticide Business License application. Any person that applies pesticides commer- cially, whether as an owner or employee of a business, is required to receive a Commercial Certi- fied Pesticide Applicator certification. Consult the Pesticide Applicator webpage for certification exam dates. 	Department of Agriculture — Division of Water Resources <u>agriculture.ks.gov/dwr</u>	The state of Kansas requires a permit for water used for industrial water purposes, including at greenhouses and nurseries, when the diversion of water is not incidental to the operation of a tradi- tional farmstead, unless water is obtained from a rural or municipal water source. Review the Kan- sas Water Law Basics. Complete the appropriate Water Appropriation Forms. 	Kansas Department of Health and Environ- ment — Bureau of Environmental Remediation, Storage Tank Section <u>kdheks.gov</u> <u>kdheks.gov/tanks</u>	Entities operating their own fuel tanks may be required to register with the Kansas Department of Health and Environment (KDHE). Review information about aboveground storage tanks (AST) and underground storage tanks (UST). 	Kansas Department of Health and Environ- ment — Bureau of Water, Industrial Program Section <u>kdheks.gov/indust</u>	An NPDES Construction Stormwater Permit is required only if one or more acres are disturbed during construction. 	Kansas Department of Health and Environ- ment — Bureau of Waste Management <u>kdheks.gov/waste</u>	Facilities producing specialized organic waste may compost or apply this material to the land. Composting facilities less than one-half acre must register with KDHE and facilities greater than one-half acre must obtain a permit. An application for approval must be obtained to apply organic waste to land. For more information, review the KDHE Solid Waste webpage or call (785) 296-2751.	Prior to composting or land application
	Bureau of Water, Public Water Supply and Geology & Well Technology Section <u>kdheks.gov/pws</u> <u>kdheks.gov/geo</u>	If the facility will not utilize a municipal public water supply or rural water supply as the source of drinking water and the facility will serve 25 people or more per day, 60 or more days per year, it will be considered a public water supply subject to state/federal drinking water requirements. Contact the KDHE Public Water Supply Section at (785) 296-5514. Water wells shall be constructed by Kansas-licensed water well contractors. There are special construction requirements for water wells serving public water supplies. Contact the KDHE Geology & Well Technology Section at (785) 296-3565 for more information. A customer record for a hemp producer not already established in Customer Relationship Management (CRM) Business Partner must be created and land not already identified in an active FSA farm must be created in CRM Farm Records. If your farm is not registered with the FSA and to report your industrial hemp acres to FSA, contact your county FSA to do so.	Prior to growing industrial hemp.
