Marshall County landowners and tenants participate in a cost share certificate only method for purchasing chemical. The program works well for us and has been a positive way to not compete with our local chemical businesses. Our goals are to continue this method and keep landowners educated on how and where they can purchase their chemicals. We have also put a strong emphasis on controlling Sericea Lespedeza by offering Escort XP free of charge.

The priorities and goals for our county do not change much from year to year. We work to keep the landowners educated and informed on the latest ways to control noxious weeds.

Describe the areas which noxious weed species are known to occur within the county and specific locations of new infestations and areas particularly susceptible to new infestations. Field bindweed Field bindweed can be found almost anywhere in the county. Overgrazed pastures and road sides are good growing conditions for Bindweed. Musk thistles can be found in pastures, waste lands, pond dams & roadsides. Overgrazed pastures are susceptible to new Musk thistle infestations. Sericea lespedeza Sericea lespedeza occurs most often in pastures and CRP. Moving hay bales containing the seed and deer grazing on it, passing it from area to area creates new infestations. Johnsongrass Johnsongrass can be found along rivers & creeks and along roadsides. With Roundup Ready crops Johnsongrass is not as bad in Marshall Co. Bur ragweed N/A Canada thistle Marshall County has a very small amount of Canada thistles. Landowners are aware of the areas and are treating it yearly. Hoary cress N/A Leafy spurge There are a few leafy spurge patches in Marshall County. I have identified them and am working with landowners to eradicate it. To notify landowners of a noxious weed problem, we mail a letter to the landowner offering the department's help for correction and eradication of the noxious weeds infesting the property. Most cases are satisfied in this manner. Only after several attempts at gaining cooperation is the legal process started. The legal process is a last resort option in Marshall County. Legal processes are approved by the Board of County Commissioners.

Marshall County does not have the state highway contract. When an infestation is found on state or federal property we contact the agency involved and offer help if needed.
