



Swine Farm Licensing Guide

The Kansas Department of Agriculture (KDA) is devoted to the total support of agriculture in Kansas. While we must fulfill our statutory obligations, the department is dedicated to providing support and assistance to make Kansas farms, ranches and agribusinesses successful and help them grow if that is their desire. We also encourage more farms, ranches and other agriculture businesses to expand in or relocate to Kansas. This checklist will help guide you through various resources and requirements for opening and operating a typical Kansas swine farm. In addition to license requirements by KDA, other Kansas agencies — as well as local or federal government agencies — may have regulatory requirements to follow. Contact your local planning authority to ensure you follow all local business development laws, rules, regulations and guidelines. This guide is designed to assist you as you work to build and operate a successful swine farm in Kansas.

	Department of Agriculture — Division of Animal Health www.agriculture.ks.gov	Operations with a one-time capacity of more than 300 animal units must complete a Swine Feedlot License application. For a multiple herd source swine genetic sale or any other occasional sale of livestock, complete the Occasional Sales Application . Interstate shipment of livestock requires official identification and certificate of veterinary inspection or other documentation. Some exemptions may exist. Consult the KDA Division of Animal Health Import and Export Regulations for a complete list of requirements or call 785-564-6601. Before exporting livestock from Kansas, contact the state of destination for their livestock import requirements. 	Department of Agriculture — Division of Water Resources www.agriculture.ks.gov	The state of Kansas requires a permit for water used for stockwatering. Stockwatering is the watering of livestock and other uses of water directly related to the operation of a feedlot with the capacity to confine 1,000 or more head of cattle, or any other confined livestock operation that would divert 15 or more acre-feet (4.88 million gallons of water) per calendar year. Any group of feedlots or confined feeding operations may be considered a single operation if there are common feeding or other physical facilities and the group of facilities is under common management. 	Department of Agriculture — Weights and Measures www.agriculture.ks.gov	No license is needed from the KDA Weights and Measures Program. Any business with a weighing or measuring device (e.g., scales, wholesale fuel meters, fertilizer meters, oil meters, grain moisture meters, electric car chargers, milk meters, etc.) must hire a licensed service company to place the device in service with the Kansas Department of Agriculture before the device may be used in commercial transactions. The businesses must hire a licensed service company to inspect and test the commercial devices once annually, and any time additional maintenance, repairs, adjustments and calibrations are made throughout the year if the devices are used to determine the cost of any transaction. Examples include scales at grocery stores, restaurants, hardware stores, nurseries, seed dealers, etc. Examples of meters include meters to dispense propane, vehicle mounted meters for fuel delivery, fertilizer meters at agronomy centers, water meters in grocery stores for sale of bottled water, etc. For more information, visit the KDA Weights and Measures Program webpage or call 785-564-6681. 	Department of Agriculture — Pesticide and Fertilizer www.agriculture.ks.gov	If the swine farm will apply effluent to crops by blending effluent with fresh water through an irrigation system, a Chemigation User's Permit will be required. Visit the KDA Chemigation webpage for additional requirements or call 785-564-6688.	Prior to chemigating Annual renewal January 1
	Department of Health and Environment — Bureau of Environmental Field Services, Livestock Waste Management Section www.kdheks.gov	Any facility that confines swine must register with the Kansas Department of Health and Environment (KDHE). Animal units can be calculated on the registration form. The need for additional permits and nutrient management plans will be determined based upon the number of animal units and pollution potential. Additional requirements may exist if a facility of any size is considering composting. For more information, contact KDHE Livestock Waste Management at 785-296-6432.	Prior to construction
	Department of Health and Environment — Bureau of Water, Industrial Programs Section www.kdheks.gov	An NPDES Construction Stormwater Permit is required only if one or more acres are disturbed during construction. The permit is required prior to the start of soil disturbing activities (construction). For more information, visit the KDHE Industrial Programs website or call 785-296-5549.	Prior to construction
	Department of Health and Environment — Bureau of Water, Municipal Permitting & Engineering Unit www.kdheks.gov www.kdhe.ks.gov/LEPP	If the facility will employ an on-site wastewater treatment system for human wastewater rather than utilize a municipal sanitary sewer for handling and disposal of sewage from the facility, contact the KDHE Municipal Permitting & Engineering Unit at 785-296-5528 for domestic wastewater permitting requirements. 	Department of Health and Environment, Bureau of Water, Public Water Supply Section and Geology & Well Technology Unit www.kdheks.gov	If the facility will not utilize a municipal public water supply or rural water supply as the source of drinking water and the facility will serve 25 people or more per day, 60 or more days per year, it will be considered a public water supply subject to state/federal drinking water requirements. Contact the KDHE Public Water Supply Section at 785-296-5514. Water wells shall be constructed by Kansas-licensed water well contractors. There are special construction requirements for water wells serving public water supplies. For more information, contact the KDHE Geology & Well Technology Unit at 785-296-7265.	Prior to construction
	Department of Health and Environment, Bureau of Environmental Remediation, Storage Tank Section www.kdheks.gov	Entities operating their own fuel tanks may be required to register with the Kansas Department of Health and Environment (KDHE). Review information about aboveground storage tanks (AST) and underground storage tanks (UST). Review the KDHE Storage Tank Section website for further information or call 785-296-1678 for permitting information. The Kansas Small Business Environmental Assistance Program (SBEAP) has AST program highlights and registration requirements in addition to assistance with UST inventory control. 	Department of Health and Environment, Bureau of Air www.kdheks.gov	Gasoline dispensing facilities are subject to federal air regulation. A guidance document is available to assist in determining regulatory requirements. Refer to the Standard Construction Permit/Approval for Gasoline Dispensing Facilities if applicable. 	Department of Wildlife and Parks (KDWP) www.ksoutdoors.com	Projects that involve public funds or government assistance, require another state or federal permit, or potentially affect a current listed species or its critical habitat need an ecological review . Contact KDWP Ecological Services at 620-672-0720 for more information. Early engagement (before project site selection) with KDWP can reduce regulatory concerns.	Prior to construction
